The Hospital facilities include 20 licensed, acute-care beds and 50 nursing home beds. The Hospital grants credit to patients, substantially all of whom are local residents. The Hospital also provides care to patients who meet certain criteria under its charity care policy without charge or at amounts less than the established rates. The Hospital does not pursue collections of amounts determined to qualify as charity care.

The Hospital maintains records to identify and monitor the level of charity care it provides. These records include the amount of charges forgone for services and supplies furnished under its charity care

The Hospital provides services to the community at large for which it receives little or no payment. Services include health evaluations, screening programs at community, and/or work and flu shot clinics.

The Hospital provided other community benefits for which no value can be placed, such as leadership in identifying community needs, staff commitment to volunteer community health organizations, advocacy, and support for the socially and physically disadvantaged, and support for local public safety organizations.
