Program details: The Upper Valley Smiles school-based sealant program was offered in 5 schools across two districts, and consisted of 412 classroom education sessions on basics of good oral hygiene. In addition, 107 children received a dental screening, and 60 low-income, uninsured children received dental sealants and topical fluoride varnish applications. 29 of those children were referred to area dentists for follow-up restorative treatment, case-managed by the Department of Community Health. A free dental clinic was held on a Saturday at APD, with 23 low income children receiving a dental cleaning and fluoride varnish application. 560 doses of flu vaccine were administered at no cost to area residents; individual assistance with the NH/VT Medicaid application (for children and pregnant women) was offered to all uninsured children in the Lebanon School District and to children/pregnant women from other community referral sources, resulting in 56 new Medicaid enrollments (and increased access to care). These initiatives continue to address several of the most pressing community health needs, as identified in the United Way 2008 Needs Assessment.
